



The Jannali High School Bring Your Own iPad (BYOiP) Student / Parent iPad equity use agreement

This agreement outlines the conditions under which The Jannali High School will make available a school owned iPad for student use on a loan-rental basis.

Students and parents/carers must read and sign this agreement, thus acknowledging their understanding and acceptance of all conditions, prior to being eligible to receive a school iPad on a loan-rental basis.

1. Equipment

- 1.1 The iPad remains the property of the Department of Education (DoE) through The Jannali High School and may be recalled at any time at the direction of the school Principal or their representative.
- 1.2 The student must bring the iPad fully charged to school every day unless advised otherwise. Chargers should be left at home.
- 1.3 The school provided cover must remain on the iPad at all times.
- 1.4 All material (including personal information) on the iPad is subject to viewing by school staff.
- 1.5 If for any reason there is a legitimate Police request to access the iPad, the school, will provide access to the iPad including any personal information stored on the iPad.
- 1.6 Loan-rentals are based on school priorities and may vary from short-term to long-term, class groups or individual students.

2. Damage or loss of equipment

- 2.1 All iPads are covered by a manufacturer's warranty. The warranty covers manufacturer's defects and normal use of the iPad. It does not cover negligence, abuse or malicious damage.
- 2.2 Any problems, vandalism, damage, loss or theft of the iPad must be reported immediately to the school.
- 2.3 In the case of suspected theft, a Police report must be made by the family and an event number provided to the school.
- 2.4 In the case of loss or accidental damage, a witnessed statutory declaration signed by a parent/carer should be provided.
- 2.5 Where an iPad is damaged or lost by neglect, abuse or malicious act, the parent/carer will be required to pay the school for the full replacement / repair costs. The Principal will determine whether the student will retain access to the school iPad.
- 2.6 Parents/carers will be required to replace lost or damaged iPad chargers.

3. Insurance repairs

- 3.1 The Jannali High School has taken out Apple Care+ insurance for the iPad. If the iPad is damaged and requires repair (outside the conditions of the manufacturer's warranty), the parent/carer will be required to pay the excess cost for any insurance claim (approximately \$65 and limited to two claims in two years)
- 3.2 The Principal will determine whether or not the student retains access to the school iPad, depending on the circumstances of how the damage occurred.

4. Financial terms of the loan-rental

- 4.1 A weekly payment of \$_____ per week (fully refundable following the personal purchase of an iPad by the family).
- 4.2 Rental of a student 'iPad' locker at a cost of \$1 per week (non-refundable) to provide security at school for the iPad before school, recess and lunch time.

5. Loan-rental timeframe

- 5.1 This loan-rental agreement is for the period: ___/___/_____ to ___/___/_____ unless there is a need for the school to exercise its right to enforce point 1.1 above.
- 5.2 The iPad must be returned to school for annual stocktake and maintenance a week prior to the end of school year.
